### Payment Agreement

Payment is due the FIRST CLASS OF EACH MONTH. Students will not be allowed to continue if payment has not been received by the 10<sup>th</sup> of the month and a **late fee of \$20.00 will be charged**. Unless NEW CITY DANCE CO. is notified full tuition is due from registered students EACH MONTH REGARDLESS IF HE/SHE HAS ATTENDED ALL CLASSES. Make up days are available in the event of an illness. Tuition is based on the overall average of classes held in the September-June season not on the individual month. Therefore tuition is the same each month and is still due the first class of every month.

I also agree to pay court costs and reasonable attorney fees incurred by NEW CITY DANCE CO. in the event of collection action on payments due herein or on any breach of this agreement.
